## **CAR DONATION FACTS (Do not fax this sheet)**

### **What can I donate?**

We accept most vehicles and vessels including but not limited to cars, trucks, trailers, motorcycles, boats and RV's.

### **Does my vehicle have to be running or driveable?**

We are able to accept most vehicles running or not (exceptions include older vehicles whose value would not offset the cost of towing). To find out if we can accept your vehicle, please complete and fax/email to us. Allow 7 days for response.

### **What do I need to donate my vehicle?**

The seller would like the title to the vehicle, but if you do not have it please fax/email us anyway. It is possible that other arrangements may be made. Your Social Security number or Federal ID number is required under current IRS guidelines.

### **Can I donate a vehicle in any state?**

Yes, we are able to pick up accepted vehicles in the continental U.S. and Hawaii.

### **To whom do I transfer title?**

NAMI Maryland

### **How will my car be picked up?**

We will arrange to have your vehicle towed away by a professionally licensed, bonded and insured towing company.

### **How long will it take to pick up my vehicle?**

We will arrange for a towing company to contact you via telephone within three to four business days at the latest. If you need your car picked up sooner, please let us know, as we are often able to accommodate.

### **Is my donation tax deductible?**

Yes, vehicle and vessel donations made to bona fide charitable organizations are tax deductible to the full extent of the law. NAMI Maryland is a registered 501(c) 3 non-profit organization. NAMI Maryland will acknowledge the donation within 30 days of your donation.

### **How does the tax deduction work?**

The IRS allows you to immediately claim a tax deduction of (a) the value of your vehicle up to \$500 OR (b) if the Kelly Blue Book (see below) value of your vehicle exceeds \$500, you must wait until the seller notifies you of the gross proceeds from the sale. The seller will mail you a postcard with that value for your tax purposes within ninety (90) days of the sale. Keep the seller's postcard for tax purposes.

### **How can I get the value of my car?**

You can get a copy of the current Kelly Blue Book value of your vehicle by going to <http://www.kbb.com/> and entering your vehicle's information. Keep a copy of value for tax purposes.

### **How long does it take to sell my car?**

There is no way to know how long it will take to sell your car. It takes between 2 weeks to 6 months. It all depends on the market and the condition of your car.
